## Adult Safeguarding Competency Training:

#### **Course Competencies:**

- Recognise an adult potentially in need of Safeguarding and take action

- Understand dignity and respect when working with individuals.
- Have knowledge of their local Multi-Agency Safeguarding Procedures.

Each course takes around 2 hours to complete

### City and Guilds Level 2 Award in Independent Advocacy:

If you are just starting out as an advocate or have an interest in advocacy then this online training course will be an ideal starting point for you.

The assignments usually take between 15 and 20 hours to complete depending on your







experience. You do not need to be working as an advocate to take this Award as it is an introduction to Independent Advocacy. On completion of the Award you will receive a City & Guilds Certificate for the Level 2 Award in Independent Advocacy.

To obtain the Level 2 Award in Independent Advocacy candidates need to complete one Core Unit.

### Core Unit 201: Understand the purpose and role of the Independent Advocate

- Identifying the principles of Independent Advocacy
- Understanding the role of an Advocate
- Access to services
- Advocacy models
- Communication
- Equality and diversity

### **Introduction to Mentoring:**

If you are just starting in a mentoring role, or have an interest in becoming a mentor then this short course will be ideal for you.
